Liverpool University Hospital NHS Foundation Trust (LUHFT) is working in conjunction with multiple innovative organisations to continually improve the service and care offered to our patients; this enables us to embrace new products and new technology.

One such product the Trust is evaluating at present is a wireless ECG and vital signs monitoring solution called RIMPulse. This revolutionary solution is capable of monitoring your ECG, heart rate, blood pressure, and oxygen saturation (SpO2) levels from any location using WiFi and Bluetooth technology.

The solution uses artificial intelligence to monitor your readings, and alerts our clinical teams when there has been a change in your condition. Clinicians will be able to remotely monitor your readings and alerts on PC's, laptops, and mobile devices. This may enable our clinicians to identify and treat your condition earlier than previously possible.





The main benefits between RIMPulse and the solutions currently in the hospital:

24 hours a day, seven days a week monitoring.	Providing you with peace of mind that your condition is being monitored continuously, even during sleep.
Ability to manually record a time when you feel unwell, dizzy, or faint by the press of a button.	Alerts our clinical team in real time for a rapid response when required; providing the ability to identify the reasons why you feel unwell.

The devices are being piloted in wards 3X, 3Y and the Heart Emergency Care (HEC) unit in the Royal Liverpool Hospital for six months on patients who would not otherwise have any form of monitoring.

Currently however, as this is a project designed to prove the system works as expected, there is no direct benefit to you and your care beyond what you would usually receive as part of your normal treatment. Upon your discharge you can provide feedback on your experience with the devices via a short questionnaire. Your feedback could help to shape future development of the solution and our methods of care — potentially including monitoring from your home.

We would greatly appreciate your consent to further evaluate these devices and provide us with your feedback as to their value in your current and future treatment requirements. Please note that participation in this trial is entirely optional and you can withdraw consent at any time for any reason.

You will be asked if you would like to take part in this trial; if you agree your consent will be added to your patient record. None of your personal information will be shared with any third parties.

Please note that setup of the RIMPulse system will involve the application of 5 ECG electrodes to your torso. This process may require the removal of chest hair to ensure the effectiveness of the ECG readings. After your course is complete the electrodes can be simply peeled off like a plaster.
